



**2026 ROCK THE OCEAN'S ECO EXCHANGE
OFFICIAL CONTEST RULES AND REGULATIONS**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. THIS CONTEST IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES OF AMERICA WHO ARE AT LEAST 18 YEARS OF AGE AT THE TIME OF ENTRY (19 YEARS OF AGE IN THE CASE ALABAMA AND NEBRASKA) AND TICKET HOLDERS OF ROCK THE OCEAN'S TORTUGA MUSIC FESTIVAL 2026. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. THE CONTEST BEGINS AT 12:00 PM ET ON APRIL 10, 2026 AND ENDS AT 11:00 PM ET ON APRIL 12, 2026. ALL ENTRIES MUST BE SUBMITTED WITHIN THE ENTRY PERIOD. THE WINNER WILL BE DETERMINED FROM ALL ELIGIBLE ENTRIES RECEIVED DURING THE ENTRY PERIOD IN ACCORDANCE WITH THE OFFICIAL RULES. OTHER RESTRICTIONS MAY APPLY.

CONTEST NAME: 2026 ROCK THE OCEAN'S ECO EXCHANGE CONTEST ("Contest"). VOID WHERE PROHIBITED BY LAW.

By entering the Contest, entrants agree to comply with and be bound by these Official Rules and the decisions of the Contest Entities (as defined below) which are final and binding in all respects. Failure to comply with these Official Rules may result in disqualification from the Contest.

SPONSOR and ADMINISTRATOR: The sponsor and administrator of the Contest is Rock The Ocean Foundation ("Administrator" or "Contest Entity") , a 501(c)(3) not-for-profit whose mission is to increase public awareness about the issues impacting the world's oceans and to support scientific research, education, and ocean conservation initiatives through benefit concerts, lifestyle apparel, brand partnerships, and entertainment industry events. Administrator will administer and conduct the Contest substantially as described in these Official Rules. By participating in the Contest each entrant agrees as follows:

ENTRY PERIOD: The Contest begins at 12:00 PM ET on April 10, 2026 and ends at 11:00 PM ET on April 12, 2026.

METHOD OF ENTRY: Enter the Contest via in-person registration at the Rock The Ocean's Tortuga Music Festival 2026 (the "Festival") produced by Rock The Ocean Productions, LLC & Live Nation Worldwide, Inc. To enter the Contest, Entrants must: (i) obtain Administrator-provided trash bags ("Bags") from the Eco Exchange booth located in the Festival's Conservation Village, (ii) collect trash and recyclables in the Bags throughout the Festival, and (iii) bring the filled Bags back to the Eco Exchange booth to be exchanged for points. Each entrant may redeem their points for various prizes available at the Eco Exchange booth with corresponding point values. Additionally, all entrants will become eligible for the Grand Prize (set forth below), which shall be awarded to the entrant who collects the most points at the end of the Entry Period. Two types of Bags are available at the Eco Exchange booth, (i) small bags for cigarette butts, and (ii) large bags for recycling. Entrants can exchange un-mixed, properly-filled Bags during the Entry Period for 1 point per Bag. Administrator attendants at the Eco Exchange will log each Bag returned and each entrant's total point balance. There is no limit to how many points can be collected by each entrant during the Entry Period, and redeeming points for the various prizes at the Eco Exchange booth shall not affect the entrant's overall total of points for purposes of Grand Prize eligibility. Entrants have the ability to collect up to a total of two (2) Bonus points during Entry Period. One(1) Bonus point is awarded to participants who come to the Eco Exchange Booth and show Administrator attendants that he/she are Following Official Rock The Ocean Social Media Platforms ("Platforms") - limited to Facebook, Instagram, and/or TikTok. One(1) Bonus point is awarded to participants who come to the Eco Exchange Booth and show Administrator attendants that he/she are Following Official VoLo Foundation Social Media Platforms ("Platforms") - limited to Facebook, Instagram, and/or TikTok. Participants are only awarded these Bonus Points ONCE during the Entry Period. ****THIS CONTEST IS IN NO WAY ADMINISTERED, SPONSORED, OR ASSOCIATED WITH INSTAGRAM, FACEBOOK, NOR TWITTER.**** In order to enter this Contest, entrants will be required to provide their name, email address, ZIP code, mobile phone number and age. One entrant per valid email address will be entered into the Contest. No third-party entry or entry through any contest service permitted. No trash or recyclables from outside of the Festival permitted. All entries become the property of the Contest Entity and none will be acknowledged or returned. Any individual who attempts or otherwise encourages, directly or indirectly, the entry of multiple or false contact information under multiple identities, or uses any device or artifice to enter or encourage, directly or indirectly, multiple or false entries, as determined by the Administrator, will be disqualified.

If, in the Administrator's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Contest, or if a computer virus, bug, unauthorized intervention, fraud, technical difficulties, or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Contest, and/or the Contest is not capable of being conducted as described in these Official Rules, Administrator shall have the right, at its sole discretion, to disqualify any individual who tampers with the entry



process and to void any entries submitted fraudulently, and/or to cancel, terminate, modify or suspend this Contest. Administrator reserves the right to prosecute any fraudulent entries to the fullest extent of the law.

ELIGIBILITY: This Contest is open to U.S. residents at least 18 years of age at time of entry (19 years of age in the case Alabama and Nebraska) and ticket holders of the Festival. The Contest Entry Period begins at 12:00 PM ET on April 10, 2026 and ends at 11:00 PM ET on April 12, 2026. All entries must be submitted within the Entry Period. Employees and agents of the Contest Entity and each of their respective affiliates, subsidiaries, successors, assigns and any entity involved in the development, production, implementation, administration, judging, or fulfillment of the Contest, including, but not necessarily limited to the immediate family members and/or those persons living in the same household of such individuals, are not eligible to participate. With respect to any winning entry, the winner may be required to provide the Administrator with proof that the person is the registered account holder of the email address associated with the winning entry.

SELECTION OF GRAND PRIZE WINNER: One (1) winner will be determined on or around 5:00 PM ET on April 13, 2026, among all eligible Contest entrants. The entrant who has collected the highest number of points from the Eco Exchange booth at the close of the Entry Period will be named the winner. The winner will be determined by the Administrator, whose decisions and interpretations on all matters relating to the Content and these Official Rules are final and binding in all respects. The Administrator reserves the right to disqualify any participant or winner and may refuse to award the prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Contest, or obtained winner status using fraudulent means. No responsibility is accepted for ineligible entries or entries made fraudulently. The Administrator's decision is final and no correspondence will be entered into.

Odds of winning the prize depend on the number of eligible entries received. The potential winner will be notified by telephone (phone call and/or text message) and/or email and must meet all eligibility requirements. Return of a prize or prize notification as undeliverable, or inability of Administrator to contact a potential winner by telephone (phone call and/or text message) or email by 12:00 PM ET on April 14, 2026, may result in disqualification of such potential winner, and an alternate winner may be selected at Administrator's discretion as set forth hereinbelow. In the event a winner declines the prize or fails to return any completed documents and releases as required, the Administrator may elect, at its discretion, to select an alternate winner, who will be the entrant with the second highest points collected from the Eco Exchange booth during the Entry Period.

The Administrator may announce/publish the winner's first name on the Festival's websites. By entering this Contest, entrants consent to such disclosure should they be a prize winner.

GRAND PRIZE/APPROXIMATE RETAIL VALUE ("ARV"): Two (2) General Admission 3-day passes to Rock The Ocean's Tortuga Music Festival 2027 ("Grand Prize"). Total ARV: \$730.00. Winners shall be responsible for the cost of their own tickets to the Festival. Administrator will NOT be providing travel to or from this Festival, accommodations, food, or sustenance which must be organized by the winner(s) at their own cost and expense.

PRIZE RESTRICTIONS: No substitution, cash redemption, or transfer of the prize(s), but the Administrator reserves the right to substitute prize(s) in whole or in part with a prize of comparable or greater value if the advertised prize becomes unavailable. An IRS Form 1099 for the fair market value of the prize(s) may be filed and a copy provided to the prize winner(s). All applicable federal, state, local, and other taxes and fees associated with the prize and expenses not stated related to acceptance and use of a prize are solely the responsibility of the winner(s). If a prize cannot be accepted as stated, the prize will be forfeited in its entirety and to the extent feasible will be awarded to an alternate winner selected at Administrator's discretion, as set forth herein. If lost, the prize(s) will not be replaced.

PUBLICITY, PRIVACY & PRIZE NOTIFICATION: Except where prohibited by law or regulation, by participating in the Contest, entrant grants the Contest Entity a perpetual, worldwide, royalty-free license to use his/her name, character, photograph, voice, and likeness in connection with the promotion of this Contest, and entrants waive any and all claims and/or rights to receive any royalties or other compensation for the Contest Entity's use thereof, unless prohibited by law. Entry into this Contest may require the entrant to enter its email address and certain other personal information. Entrants are informed that the personal data collection in connection with this Contest will be collected by Administrator's servers and computer systems, which are based in the United States and such collection will therefore be subject to applicable United States laws. You may withdraw your personal data upon request; however, you will be disqualified as an entrant in this Contest if you withdraw your personal data prior to the determination of the winner(s) and fulfillment of the prize(s). The winner may be required to complete, sign, notarize and return an affidavit of eligibility/liability release and a publicity release, which must be returned, properly executed, within three (3) days of issuance of the Grand Prize notification. If these documents are not returned properly executed, or are returned to Administrator as undeliverable, or if any given prize winner does not



otherwise comply with the Official Rules, the Grand Prize will be forfeited and awarded to an alternate winner, as set forth herein.

By participating, entrants (a) release the Contest Entity, and its parent companies, affiliates, subsidiaries, successors, assigns, agents, representatives, officers, directors, shareholders, and employees, from any and all liability for any claims, costs, injuries, losses or damages of any kind, including without limitation, any property damage, personal injury and/or death, caused by preparation for, travel to or participation in the Contest, including the unauthorized or illegal access to personally identifiable or sensitive information or acceptance, possession, use, misuse, or nonuse of the prize that may be awarded; (b) acknowledge that said parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee, expressed or implied, in fact or in law, relative to a prize including, without limitation, the prize quality or availability. If for any reason the Contest is not capable of being executed as planned, or infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures or any other causes which in the opinion of the Administrator, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Contest, the Administrator reserves the right at its sole discretion to disqualify any suspect entry or entrant and to cancel, terminate, modify or suspend the Contest. In the event of any cancellation, termination or suspension, the determination of the winners will be made, from among all eligible, non-suspect entries received as of the date of the termination, cancellation or suspension, as the Administrator determines in its sole discretion. Entries not complying with all rules are subject to disqualification.

DISPUTES: Entrants and guests agree that (a) any and all disputes, claims and causes of action arising out of, or connected with, the Contest for the prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the courts located in Davidson County, Tennessee; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest but in no event attorneys' fees; and (c) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to, claim punitive, incidental and consequential damages and any other damages, other than out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Contest Entity in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules (whether of the State of Tennessee or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Tennessee.
