



**2026 ROCK THE OCEAN  
OFFICIAL RAFFLE RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. THIS RAFFLE IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES OF AMERICA WHO ARE AT LEAST 18 YEARS OF AGE AT THE TIME OF ENTRY (19 YEARS OF AGE IN THE CASE OF ALABAMA AND NEBRASKA) AND TICKET HOLDERS OF ROCK THE OCEAN'S TORTUGA MUSIC FESTIVAL 2026. ENTRY IN THIS RAFFLE CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. THE RAFFLE BEGINS AT 10:00 AM ET ON APRIL 10, 2026 AND ENDS AT 7:30 PM ET ON APRIL 12, 2026; PROVIDED, HOWEVER, THAT CERTAIN PRIZE ENTRY PERIODS END AT EARLIER DATES AND TIMES AS SPECIFICALLY SET FORTH HEREIN FOR EACH PRIZE. ALL ENTRIES MUST BE SUBMITTED WITHIN THE RESPECTIVE ENTRY PERIOD. ONE WINNER PER PRIZE WILL BE CHOSEN RANDOMLY FROM ALL ELIGIBLE ENTRIES RECEIVED DURING THE RESPECTIVE ENTRY PERIOD AND IN ACCORDANCE WITH THE OFFICIAL RULES. OTHER RESTRICTIONS MAY APPLY.

RAFFLE NAME: 2026 ROCK THE OCEAN RAFFLE ("Raffle"). VOID WHERE PROHIBITED BY LAW.

By entering the Raffle, entrants agree to comply with and be bound by these Official Rules and the decisions of the Raffle Entities (as defined below) which are final and binding in all respects. Failure to comply with these Official Rules may result in disqualification from the Raffle.

SPONSOR and ADMINISTRATOR: The sponsor and administrator of the Raffle is Rock The Ocean Foundation ("RTOF") ("Administrator" or "Raffle Entity"), a 501(c)(3) not-for-profit whose mission is to increase public awareness about the issues impacting the world's oceans and to support scientific research, education, and ocean conservation initiatives through benefit concerts, lifestyle apparel, brand partnerships, and entertainment industry events. Prizes available in the Raffle have been donated to or funded by the Administrator. Administrator will administer and conduct the Raffle substantially as described in these Official Rules. By participating in the Raffle each entrant agrees as follows:

ENTRY PERIOD: The entry period for entering this Raffle begins at 10:00 AM ET on April 10, 2026 and ends at 7:30 PM ET on April 12, 2026; **provided, however, that certain Prize entry periods end at earlier dates and times as specifically set forth in the PRIZES section herein.**

METHODS OF ENTRY: Eligible individuals may enter the Raffle: (1) by purchasing raffle tickets online through the GiveSmart Event Platform from the Rock The Ocean's Tortuga Music Festival 2026 Online Campaign ("Online Entry"); or (2) without purchase via in-person registration at the Rock The Ocean's Tortuga Music Festival 2026 (the "Festival") produced by Rock The Ocean Productions, LLC & Live Nation Entertainment ("In-Person Entry"). For In-Person Entries, Entrants must visit either (i) the Rock The Ocean Headquarters Tent in Conservation Village, or (ii) the Rock The Ocean Auction Headquarters Tent in VIP in order to enter the Raffle. In order to enter this Raffle, entrants will be required to provide their name, email address, address, ZIP code, mobile phone and age. With respect to Online Entries, tickets are available for purchase at the suggested donation amount of five dollars (\$5.00) each, six (6) tickets for twenty dollars (\$20.00), fifteen (15) tickets for fifty dollars (\$50.00), or forty (40) tickets for one hundred dollars (\$100.00) for all Prizes listed below with the exception of Prize 6, and such suggested donations can be made by Visa, MasterCard, Discover, American Express, Google Pay or Apple Pay. For Prize 6 tickets are available for purchase at the suggested donation amount of ten dollars (\$10.00) each, six (6) tickets for fifty dollars (\$50.00), fifteen (15) tickets for one hundred dollars (\$100.00), or forty (40) tickets for two hundred dollars (\$200.00), and such suggested donations can be made by Visa, MasterCard, Discover, American Express, Google Pay or Apple Pay. Mail-in entries are not accepted. All sales transactions are final. No payments will be refunded unless the Raffle is canceled. One entry per raffle ticket via Online Entry and one entry per In-Person Entry will be entered into the Raffle. Only entries submitted during the specified Raffle entry period will count. No third-party entry or entry through any contest service permitted. All entries become the property of the Raffle Entity and none will be acknowledged or returned. Any individual who attempts or otherwise encourages, directly or indirectly, the entry of false contact information under multiple identities, or uses any device or artifice to enter or encourage, directly or indirectly, false entries, as determined by the Administrator, will be disqualified.

If, in the Administrator's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Raffle, or if a computer virus, bug, unauthorized intervention, fraud, technical difficulties, or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Raffle, and/or the Raffle is not capable of being conducted as described in these Official Rules, Administrator shall have the right, at their sole discretion, to disqualify any individual who tampers with the entry



process and to void any entries submitted fraudulently, and/or to cancel, terminate, modify or suspend this Raffle. Administrator reserves the right to prosecute any fraudulent entries to the fullest extent of the law.

**ELIGIBILITY:** This competition is open to U.S. residents who are at least 18 years of age at time of entry (19 years of age in the case of Alabama and Nebraska) and are ticket holders of the Festival. The Raffle Entry Period begins at 10:00 AM ET on April 10, 2026 and ends at 7:30 PM ET on April 12, 2026; **provided, however, that certain Prize Entry Periods end at earlier dates and times as specifically set forth in the PRIZES section herein.** All entries for each Prize must be submitted within the respective Entry Period as set forth in the PRIZES section. Employees and agents of the Raffle Entity and each of their respective affiliates, subsidiaries, successors, assigns and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Raffle, including, but not necessarily limited to the immediate family members and/or those persons living in the same household of such individuals, are not eligible to participate. With respect to any winning entry, the winner may be required to provide the Administrator with proof that the person is the registered account holder of the email address associated with the winning entry.

**SELECTION OF WINNERS:** All eligible entries for each Prize will be entered into a drawing. One (1) winner per Prize will be selected on or around 3:30PM ET for the "Ticket Upgrade" Prizes and on or around 7:30 PM ET on for each of the following items: Two (2) GA Tickets to Tortuga Music Festival 2027, Two (2) VIP Tickets to Tortuga Music Festival 2027, Two (2) SVIP Tickets to Tortuga Music Festival 2027, Rock The Ocean Chill Bundle, and Rock The Ocean Beach Bundle on April 10, 11, and 12, 2026, as applicable, in a random drawing among all eligible entries received for such Prize. Prizes are subject to change after Raffle Begins in which a drawing time for any new Prize will be determined. Any new Prize will have one (1) winner per prize and will have a random drawing among all eligible entries received for such Prize. Each winner will have thirty (30) minutes after such. Prize is drawn and the winner is contacted by telephone (call and/or text message) to claim their respective Prize. The drawing will be conducted by the Administrator utilizing a randomizer selection application, and Administrator's decisions and interpretations on all matters relating to the Raffle and these Official Rules are final and binding in all respects. The Administrator reserves the right to disqualify any participant or winner and may refuse to award the respective Prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Raffle, or obtained winner status using fraudulent means. No responsibility is accepted for ineligible entries or entries made fraudulently. The Administrator's decision is final and no correspondence will be entered into.

Odds of winning the Prizes depend on the number of eligible entries received for each Prize. All entries are considered equally. Potential winners will be notified by telephone (call and/or text message) and/or email and must meet all eligibility requirements. **Return of a Prize or Prize notification as undeliverable, or inability of Administrator to contact a potential winner by telephone (call and/or text message) within thirty (30) minutes after such Prize is drawn and the winner is contacted, may result in disqualification of such potential winner, and an alternate winner may be selected by random drawing at Administrator's discretion.** In the event a winner declines their Prize or fails to return any completed documents and releases as required, the Administrator may elect, at its discretion, to select an alternate winner by random drawing.

The Administrator may announce/publish the winners' first names on the Festival's websites. By entering this competition, entrants consent to such disclosure should they be one of the Prize winners.

**PRIZES:** Subject to these Official Rules, only the prizes set forth below will be awarded in connection with the Raffle (each a "Prize" and collectively the "Prizes"). 9. Prizes are subject to change, additional Prize/s may be added once Raffle begins. For a final list of all Raffle Prize details once Raffle ends, including Item Number and Raffle Entry Close Time, mail a self-addressed stamped envelope by first class mail to: Rock The Ocean Foundation, 1212 8<sup>th</sup> Avenue South, Nashville, TN 37203.

**PRIZE SELECTION PROCEDURES:** Entrants may purchase raffle tickets and/or submit In-Person Entries for one (1) or more specific Prize. One winner will be drawn for each Prize from the pool of entrants for each respective Prize. All In-Person Entries and Online Entries are considered equally.

**PRIZE RESTRICTIONS:** No substitution, cash redemption or transfer of Prize(s), but the Administrator reserves the right to substitute Prize(s) in whole or in part with Prize of comparable or greater value if the advertised Prize becomes unavailable. An IRS Form 1099 for the fair market value of the Prizes will be filed and a copy provided to the Prize winners. All applicable federal, state, local and other taxes and fees associated with the Prizes and expenses not stated related to acceptance and use of a Prize, including without limitation telephone calls, or SMS fees, are solely the responsibility of the winners. If a Prize cannot be accepted as stated, the Prize will be forfeited in its entirety and to the extent feasible will be awarded to an alternate winner selected by random drawing at Administrator's discretion. If lost, the Prize will not be replaced.

**PUBLICITY, PRIVACY & PRIZE NOTIFICATION:** Except where prohibited by law or regulation, by submitting an entry, entrant grants the Raffle Entity a perpetual, worldwide, royalty-free license to use his/her name, character, photograph, voice, and likeness in connection with the promotion of this Raffle, and entrants waive any and all claims and/or rights to receive any royalties or other compensation for the Raffle Entity's use thereof, unless prohibited by law. Entry into this Raffle may require the entrant to enter its email address and certain other personal information. Entrants are informed that the personal data collection in connection with this Raffle will be collected by Administrator's servers and computer systems, which are based in the United States and such collection will therefore be subject to applicable United States laws. You may withdraw your personal data upon request; however, you will be disqualified as an entrant in this Raffle if you withdraw your personal data prior to the determination of the winner(s) and fulfillment of the Prize(s). The winners may be required to complete, sign, notarize and return an affidavit of eligibility/liability release and a publicity release. If these documents are not returned properly executed, or are returned to Administrator as undeliverable, or if any given Prize winner does not otherwise comply with the Official Rules, the Prize(s) may be forfeited and may be awarded to an alternate winner.

**GENERAL CONDITIONS/RELEASE:** The Raffle is void where prohibited by law and is governed by the laws of the United States of America. The submission of an entry is solely the responsibility of the entrant. Only eligible entries actually received during the specified Raffle entry period for each Prize will be included in such Prize drawing. Any automated receipt (such as one confirming delivery of e-mail) does not constitute proof of actual receipt by Administrator of an entry for purposes of these Official Rules. By participating, entrants (a) release the Raffle Entity, and its parent companies, affiliates, subsidiaries, successors, assigns, agents, representatives, officers, directors, shareholders, and employees, from any and all liability for any claims, costs, injuries, losses or damages of any kind, including without limitation, any property damage, personal injury and/or death, caused by preparation for, travel to or participation in the Raffle, including the unauthorized or illegal access to personally identifiable or sensitive information or acceptance, possession, use, misuse, or nonuse of the Prize that may be awarded; (b) acknowledge that said parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee, expressed or implied, in fact or in law, relative to a prize including, without limitation, the Prize quality or availability. The Raffle Entity is not responsible if the Raffle cannot take place or if any Prize cannot be awarded due to travel cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather or acts of terrorism; and (c) acknowledge that Administrator is solely responsible for administering the Raffle and furnishing the Prizes, and Sponsor shall have no liability in connection therewith or otherwise in connection with the Raffle. Neither the Raffle Entity nor any service providers are responsible for incorrect or inaccurate transcription of entry information, or for any human or other error, technical malfunctions, lost/delayed data or voice transmission, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, inability to access any online service or to complete a telephone call or facsimile transaction, or any other error or malfunction, or late, lost or misdirected mail, or any injury or damage to participant's or any other person's computer or television related to or resulting from participation in this Raffle. **CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY TAMPER WITH THE ENTRY PROCESS, OR OTHERWISE UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO COOPERATE IN THE PROSECUTION OF ANY SUCH INDIVIDUAL(S) AND TO PURSUE ALL REMEDIES TO THE FULLEST EXTENT PERMITTED BY LAW.** Raffle Entity's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. If for any reason the Raffle is not capable of being executed as planned, or infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures or any other causes which in the opinion of the Administrator, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Raffle, the Administrator reserves the right at its sole discretion to disqualify any



suspect entry or entrant and to cancel, terminate, modify or suspend the Raffle. In the event of any cancellation, termination or suspension, the determination of the winners will be made, from among all eligible, non-suspect entries received as of the date of the termination, cancellation or suspension, as the Administrator determines in its sole discretion. Entries not complying with all rules are subject to disqualification.

**DISPUTES:** Entrants and guests agree that (a) any and all disputes, claims and causes of action arising out of, or connected with, the Raffle for any Prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the courts located in Davidson County, Tennessee; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Raffle but in no event attorneys' fees; and (c) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to, claim punitive, incidental and consequential damages and any other damages, other than out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Raffle Entity in connection with the Raffle, shall be governed by, and construed in accordance with, the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules (whether of the State of Tennessee or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Tennessee.
