April 6, 2026 at 12:00 PM EST through April 12, 2026 at 7:30 PM EST

By bidding in the Rock The Ocean Foundation's Tortuga Music Festival 2026 Fundraising Auction, each bidder agrees to these auction rules.

1. All sales are final. There will be no exchanges or refunds unless otherwise noted. All items are "as is."
2. Rock The Ocean Foundation ("RTOF") has attempted to describe and catalog items correctly, but RTOF neither warrants nor represents and in no event shall be responsible for the correctness of descriptions, genuineness, authorship, provenance, or condition of the items. No statement made in the description of auction items, or made orally at the auction or elsewhere, shall be deemed such a warranty, representation, or assumption of liability.
3. The auction item value listed is an estimate of the fair market value. Items have not been appraised unless so noted. The amount you pay above this fair market value estimate is normally tax deductible as a charitable contribution. Please consult your tax adviser to clarify the amount of deduction.
4. Payment for items purchased must be made in full on the night of the auction to RTOF's designated representative(s) or via the GiveSmart platform. RTOF accepts credit card or check payments made payable to "Rock The Ocean Foundation".
5. If applicable, the purchaser must pick up all items the night of the auction, unless special arrangements are made. If shipping is required, a shipping fee of \$150 plus applicable transaction/credit card fees per item will apply. Any item/s left unclaimed, without prior arrangements, may be sold and proceeds will go to Rock The Ocean Foundation.
6. RTOF reserves the right to add or withdraw items, without notice, to or from the Auction.
7. This auction may contain items with multiple options available. For example there may be more than one guitar of the same design available. Each item will be listed by design (i.e. Tortuga, Shark, Palm Tree, etc). Autographs may vary on any item that is being autographed by multiple artists. Although RTOF cannot guarantee which artists sign which item/s, RTOF will provide authentication photos to any winning bidder following the auction.
8. All bidder/s must be registered in the GiveSmart Platform, in person at Rock The Ocean Auction Headquarters in VIP, or in person at Rock The Ocean Headquarters in Conservation Village. Bids will only be accepted via the GiveSmart Platform or in person at either Rock The Ocean Auction Headquarters in VIP or Rock The Ocean Headquarters in Conservation Village and applied to GiveSmart by a RTOF staff member.
9. Each person bidding assumes all risks and hazards related to the auction and items obtained at the auction. Each bidder agrees to hold harmless from any liability arising indirectly from Rock The Ocean, Rock The Ocean Productions, LLC, Rock The Ocean Foundation 501(c)(3), Live Nation Worldwide, Inc., CN Holdco, LLC, TMF Holdco, LLC,
